3. GLX & CPX

- Discussed current GLX/CPX status
- Maintenance of a future completed CPX is not determined at this point

- St. Clement School 579 Boston Avenue, Medford
- McGrath bike/ped connections on and to CPX west of Gilman Street and railroad Bridges
 - Poor bike access on bridge. Bike lanes were added to design, but they're not protected from the high-speed vehicle traffic.
 - Possibility of improving the design before construction, but would require advocacy.
 Lynn to draft letter to MassDOT
 - Grand Junction Path
 - New GJP group in Cambridge
 - There is no feasibility study yet for connecting the CPX to GJP
 - Cambridge may do such a feasibility study, as the GJP connects Cambridge to Cambridge
 - Ethanol rail routes
 - Train routes run through Somerville, and put the community and the SCP at risk, with no damage liability for Global Oil, who would receive the trains.
 - 6/5 meeting in Cambridge (Lynn to attend): Routes, challenges, support, Chapter 91 amendment proposal

4. Cedar-to Lowell CPX section

- Groundbreaking ceremony
- Update: Ramp width and flooring material
 - Ramp coming back to Lowell St @ VNA is 8 ft wide, city thinks it cannot be wider. Construction firm thinks it can be. Alan to contact contractor
- Synthetic surfaces: Maintenance and alternatives
 - Some synthetic turf material by benches, but alternative is concrete, so not much to oppose there.
- Maxwell's Green
 - Mitigation money (\$220k) is in escrow
 - What should it be used for?
 - Fix drainage on Willow/Cedar section?
 - Path access Update: Curb cuts and obstructing gate
 - City will enforce curb cuts to be made at the Warwick Street corner
 - Gate is broken and needs to be replaced, so Alan has sent suggestions for bikefriendly gates to George Proakis at the city
 - Dog park next to path
 - Was already approved by City
 - Appeal process is complex, first building commisioner, then zoning board of appeals, then district court.
 - ٠
 - Path fill
 - Extensive ponding/flooding on undeveloped path area in Cedar/Lowell segment.
 - Lots of extra Maxwell's Green fill available, but of unknown quality for drainage. Maxwell's Green wants the fill used for CPX.
 - City can test dumped soil for drainage.

- Frank registered a space, rented 6' table and folding chairs, same as last year. Has two easels. Our space is next to STEP.
- Unknown but doubtful if bike committee will attend. We will propose that we use their tent.

6. Strategic Planning/Outreach

• State Transportation funding bill

- Conference Committee hashing out the transportation bill and the budget.
- Lynn to draft letter + ethanol amendments to Conference Committee and FCP supporters
- More letters needed to Conference Committee members and then legislature: Need a plan in place for 'state of good repair' for entire system in order to be eligible for New Starts. State must show that they've allocated enough to maintain vehicles and to maintain the system.

- MAPC Metrics Report
 - We received the final metrics report. It will be posted online.
- Nicole Freedman (Lynn)
 - Boston Bike Czar
 - Meeting postponed indefinitely due to developments in the CPX/GLX situation
- 5/7, 4-6 pm DCR Lower Basin subcommittee (on Charles river bike/ped bridges) FCP (Alan/Lynn presented)
 - Harborwalk and Northpoint paths were developed via permitting leverage from Boston and Cambridge. Somerville doesn't ask the same thing of their developers.
- 5/15, 6:00-8:00 PM Grounding McGrath planning study Public meeting
 - (Heather, Alan) Not too much progress towards the vision of a smaller McGrath. It's not elevated in current proposal, but number of lanes remains equivalent.
 - (Heather) One problem is that traffic projections must be made using models which assume a 1% increase in traffic per year, which doesn't match the 1/2% decrease per year which McGrath has seen.

 - Very general meeting, including land use, heights, etc.
